Analysis of Assessment Findings - SPRING SEMESTER

Spring semester findings primarily mimicked findings from previous semesters. Spring semester was characterized by small class sessions – the largest class size of the semester was 12 students. Class sizes ranged from 6-12 students.

This meant that any slight falter in student object attainment resulted in a lower benchmark.

Issues in Aging, Macro, and Child Welfare were all taught for the first time under these faculty. Issues in Aging "friendly visits" were great, but the instructor is unsure whether she will continue incorporating them into the class as pedagogically, results were mixed. Marriage and Family, compared to last year, went as expected. Due to poor performance on one assignment in a small class size, benchmark was missed in one area. One key assignment in 2018 (a paper) was substituted for a quiz (2019). There was a marked improvement in competency attainment from last year to this year. In 2018 competency benchmark was missed 4/5, in 2019 1/5.

The only repeat course for Shanks was Social Work and Law.

Findings represent a small but noticeable strengthening in student attainment of course/program objectives.

Sharing and Discussion of Assessment Findings - SPRING SEMESTER

Assessment findings are discussed with all social work faculty (presently, Profs. Ackerman and Shanks). Upon comparing notes from FCAR and course objective attainment results, overall findings were positive and in-line with expectations. Discussion surrounding an emerging question for students who take practicum over multiple semesters was discussed. More details below.

Use of Assessment Findings for Program Improvement (Action Plan) - SPRING SEMESTER

For students who complete practicum over multiple semesters, the Theory of Helping paper will be revisited in subsequent semesters. Students may add a small section or addendum to the paper addressing their new practice context.

Full Year Reflection - FALL/INTERTERM/SPRING TERMS

We are not in charge of our program learning objectives, they are prescribed by our accrediting body and cannot be changed. Therefore, no changes are forecast at this time. We have chosen assignments carefully to evaluate course and program objectives and no changes are necessary at this time. While small tweaks may be made to assignment format (eg presentation vs paper), signature assignments do not need significant review. Because last year was a baseline for data collection, there were no major action items or timeline considerations to follow.
